More national certifications are becoming available as additional organizations throw their hat into the certification ring.

The National Association for Legal Professionals, formerly National Association of Legal Secretaries (NALS), now offers the Certified Paralegal Professional (CCP) designation. The examination is divided into four parts: legal knowledge and skills, ethics and judgment skills, written communications, and substantive law. The certification is valid for five years and requires 75 hours of CLE for re-certification. Non-members may sit for the exam. Candidates must have one of the following: (1) five years of legal experience; (2) post secondary degree, other certification or a paralegal certificate and four years of legal experience; and (3) paralegal degree with three years experience.

The National Association of Legal Assistants (NALA) continues to offer its Certified Legal Assistant (CLA) designation. The criteria for sitting for the examination have not been changed. However, candidates successfully completing certification may choose between the CLA designation or the CP, Certified Paralegal, designation. While NALA feels the terms "legal assistant" and "paralegal" are interchangeable, such as "attorney" and "lawyer", the change is to accommodate preferences emerging in various regions of the country. The designations may not be used together, CLA/CP, as this may indicate two certifications.

The National Federation of Paralegal Associations (NFPA) has changed the requirements for sitting for its PACE examination: (1) associate degree in paralegal studies from an institutionally accredited or ABA-approved paralegal education program with six years experience; (2) bachelor's degree in any field with three years experience; (3) bachelor's degree and completion of a paralegal program at an institutionally accredited school that may be embodied in the bachelor's degree, with two years experience; and (4) four years of experience by December 31, 2000. Candidates successfully completing the examination may use the designation Registered Paralegal (RP).

### PASSE PARTOUT

North Carolina has introduced the Paralegal profession Act, HB 957, to the state legislature which would create a 19-member paralegal regulation board with broad authority over the state's paralegals. The bill delineates educational qualifications for paralegals and grants power to the board to establish continuing educational requirements.

The New Jersey Supreme Court Committee on Regulation has recommended creation of a state agency to oversee legal assistant practice and has recommended ethics rule changes and minimum hour and course-content standards for licensure.

South Carolina is debating minimum requirements for those designated as paralegals.

D. Jeffrey Campbell has been serving as chairman of the ABA Standing Committee on Legal Assistants (SCOLA) and is convinced that paralegals are a precious resource. So convinced is he that he has been instrumental in his firm's hiring more paralegals than attorneys, 75 paralegals and 69 attorneys.

On January 22, 2003, a new national paralegal association was incorporated. The American Alliance of Paralegals membership is available to anyone currently employed as a paralegal with a minimum of six years of formal education and/or paralegal experience, with associate and sustaining memberships to those not meeting the minimum membership requirements.
